3. Payment

5. Safety and Emergency Procedures

- **Emergency Contact Information:** Below is a list of emergency contacts;

The Babysitter should keep this information readily available in case of an emergency.

- **Medical and Allergy Information:** The Babysitter shall be provided with known allergies, medical conditions, required medications and emergency treatment procedures. The Babysitter agrees to be familiar with the child’s specific medical needs and follow any instructions provided by the Employer.
- **Safety Precautions:** The Babysitter agrees to comply with all safety precautions established by the Employer such as childproofing measures, proper use of safety gates, securing hazardous items or areas, supervising the child in potentially dangerous situations.

- **Emergency Preparedness:** In the event of an emergency, the Babysitter accepts to prioritize the safety of the child.
- **Fire Safety:** The Babysitter should understand the fire evacuation procedures set by the Employer. These procedures include identifying primary and secondary escape routes and gathering points.

6. Term and Termination

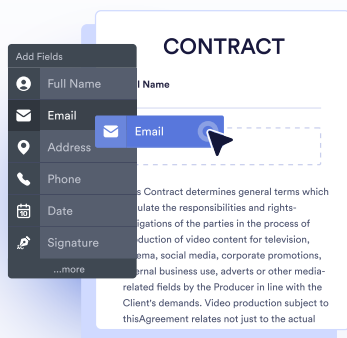

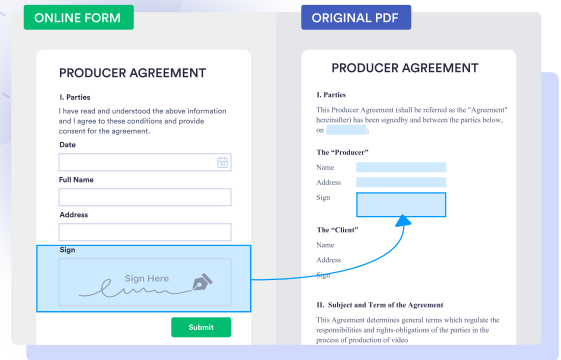
