#### **Overview**

The Influencer and the Photographer agrees that the Photographer shall provide wide range phography services to the Photographer for the creation of digital marketing material to be used for promotional purposes on the Influencer's social media channels, website, marketing materials, or other agreed-upon platforms within the scope of their advertisement and collaborations.

#### **Commencement and Term**

This Contract shall commence on \_\_\_\_\_\_ and shall remain in force until all service requirements are fulfilled in accordance with the Influencer's campaign and delivered to the Influencer, unless terminated earlier by either Party.

## Scope of Service

The Photographer shall provide professional photography services for Influencer encompassing product images and fiction videos compatible with advertising agreements as agreed between both parties. The digital material which is subject to this Contract shall be consistent with the Influencer's visual identity, style, and messaging.

The Influencer is entitled to work at times and places as the Influencer deem convenient and appropriate. The Photographer will not be under the direction or control of the Client or in any manner.

## **Copyright Ownership**

The Photographer acknowledges and agrees that all photographs produced during the photography session for Influencer shall be considered works made for hire and shall be the exclusive property of the Influencer. The Photographer hereby transfers and assigns all rights, title, and interest in and to the photographs, including but not limited to copyright, moral rights, and any other intellectual property rights, to the Influencer. The Influencer shall have the unrestricted and exclusive right to use, reproduce, display, distribute, publish, and modify the photographs for any purposes, including but not limited to social media, website, marketing, promotional materials, and any other lawful purposes without further consent from the Photographer.




