## 2. General Terms of the Adoption

- The Adopter hereby agrees that the described animal above, hereinafter known as the Pet, is being adopted by the Adopter. The Adopter undertakes that the pet will be cared for by himself/herself and his/her family.

- The Adopter agrees not to sell, dispose, or give away the Pet to any reason and shall take care of the Pet with utmost care and diligence as a member of the family. The Adopter knows and accepts that in case of torture and ill-treatment of the animal, the criminal responsibility stipulated by the applicable law will be his/her own.
- In case the Adopter is no longer capable of taking care of the Pet, the Adopter shall first to get in touch with the Owner to the exercise of the right of first refusal.
- The Adopter hereby agrees to provide the Pet clean and adequate shelter, food and veterinary care. The Adopter hereby declares of his/her awareness of the applicable local and state laws in the care and responsibility in animal care.

### 3. Other Provisions

**Separability Clause** - In case that any provisions of this Agreement be held invalid by any competent court, the same shall apply only to the said provision and the remaining provisions shall remain valid and enforceable.

**Agreement Modification** - No modification or alteration in this Agreement shall be considered as having been made unless otherwise executed in writing and signed by both the Adopter and the Owner.

**Non-waiver** - No waiver of any party shall be considered of any breach committed by another unless by express written consent and duly signed by the party aggrieved has been made.

**Governing Law** - This Agreement shall be construed and governed by the laws of the state of \_\_\_\_\_.

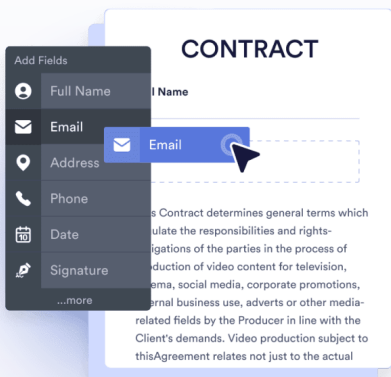

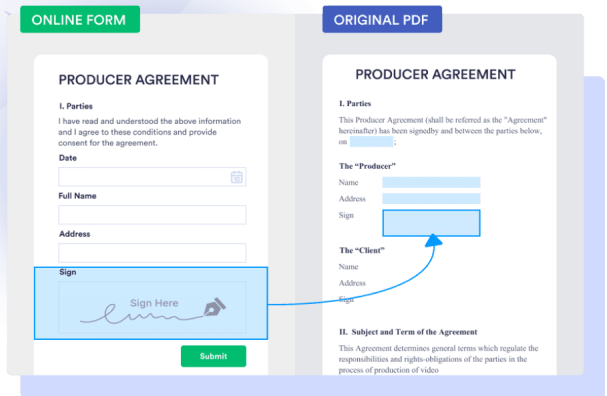
